1. Terms and Conditions

Club 100 Participation Terms

1. Eligibility: Membership in Club 100 is open to individuals aged 18 and over.
2. Membership Fee: A monthly fee of £10 is required to join Club 100. Payments will be collected through standing orders. Members should make sure that their membership of the Club is up to date on the 10th of the month in which a draw is being made.
3. Duration: Membership is ongoing until cancelled. Members may cancel but we kindly ask for written notice at least one month in advance.(Email or text is fine)
4. Prize Draws: Participants will be entered into monthly prize draws. Prize amounts will be communicated in advance. Total Prize fund is 30% of all membership payments. The draw will usually take place on the 3rd Friday of each month starting February 20th 2026. Winners will be notified by email or phone.
5. Use of Funds: 70% Funds raised through Club 100 will be allocated to support Barge No. 9 CiC and Anchor Point House and its well-being programmes.
6. Updates: Members will receive regular updates on Club activities, prize winners, and other related information via email.

7. Data Protection: Personal information provided by members will be stored securely and used solely for administering Club 100 activities.

T & C Details

1. Each new 100 Club member buys a number from 1 to a 100 which is allocated by Barge No. 9 CIC. The previous years' members will usually keep their number(s).

2. 100 Club members may request a specific membership number provided that the requested number has not already been allocated. Existing members will keep their membership number(s) each month and yearly unless otherwise requested to the 100 Club Manager (details on page 2).

3. 100 Club members should make sure that their membership of the Club is up to date on the 10th of the month in which a draw is being made. The first draw will take place on February 20th 2026.

4. If all 100 membership numbers have been sold the prize money will be: 1st £150 (15%), 2nd £100 (10%), 3rd £50 (5%) These percentages of prize money to total takings will be maintained if the number of members in a draw is less than 100.

5. We will notify you by email and text. If you win, a bank transfer will be made directly to your account, or a cheque will be posted to your home address.

6. Unclaimed prize money will be kept for six months before being transferred to Barge No.9 CIC account.

7. Promoter: Barge No. 9 CIC, Director Rosemarie Owen, c/o Anchor Point House, Tennyson Road, Lowestoft.

8. Barge No. 9 100 Club operates in compliance with lottery regulations. The 100 Club has the approval of East Suffolk Council.
